



If it's time to purchase a new refrigerator, dishwasher, clothes washer, or water heater, Kirkwood Meadows Public Utility District ("District") offers rebates for the purchase and installation of EnergyStar® appliances and energy-efficient electric water heaters.

If you're looking to switch from propane to electric, or otherwise upgrade your older electric heating system, the District offers a variety of rebate programs on several types of systems.

Program Guidelines:

- The program is limited to District residential electric service customers with all KMPUD accounts in good standing.
- The appliance and/or heating system must be installed in a residential dwelling within the District's service area.
- The rebate offer is good for purchases of electric appliances and/or heating systems only, on a first-come, first-service basis and is effective until funding is reserved/expended annually, or the program is discontinued by the District.
- A maximum of one rebate type (refrigerator, water heater, etc.) per account every 10 years.
- Applications will **only** be accepted from March 1 to March 31 and September 1 to September 30 annually.
- Applicants must submit Part One of the application **prior** to purchase or installation to reserve rebate funds. Customers will be notified within 30 days of the application period closing if their application was approved.
- Purchase and installation must be completed within 6 months from application date and approval. All equipment must be new.
- Applicants must submit Part Two of the application **after** purchase and installation to receive rebate funds.
- Customer agrees to inspection by District Staff to verify installation.
- The rebate will not exceed the purchase price. The total rebate amount may not exceed \$1,000 per customer per year.
- The rebate will be credited on the subsequent bill following completion.
- New construction (residences less than 5 years old) are not eligible.
